General Terms and Conditions for the Purchase of Publications

All prices for publications include the statutory value-added tax (VAT). In Germany, there are fixed retail prices for books. Orders made by private persons from all other European countries are billed with the current sales tax applicable in the country of the recipient. For book deliveries, shipping and handling costs are added. These are calculated based on the size, weight and destination of the shipment. You will be billed upon delivery. Please understand that we must ask non-members and non-paying members to pay the respective invoice amount in advance. In this case, billing takes place immediately, and the resulting invoice is payable immediately and without deduction. Shipment follows directly after receipt of payment. Due to the current corona situation, delays in delivery may result in line with production.

Cancellation Policy

You have the right to cancel the order within fourteen days without stating a reason. The cancellation period ends fourteen days after the date that you, or a third party named by you who was not involved in the delivery, have taken possession of the last item ordered. In order to effect cancellation, you must inform us, i.e.

in a clear declaration (e.g. a letter sent by mail, fax or email) of your decision to cancel the order. For this purpose, you may use the standard cancellation form available at tekom.eu/tekom/downloads, though this is not mandatory. To meet the deadline for cancellation, it is sufficient to send notification before the expiration of the cancellation period declaring that you are exercising the right to cancel.

After Cancellation

If you cancel your order, you must send the goods back or hand them over to us without delay and, in any event, at the latest within fourteen days from the date on which you informed us of the cancellation of your order. The deadline is met if you send the goods before expiration of the fourteen-day period. You bear the immediate costs of the return of the goods. You are only liable for payment for any possible loss in value of the goods if this loss in value can be traced back to any handling by you that was unnecessary to ascertain the condition, properties or functionality of the goods. We must refund to you all payments that we have received from you, including delivery costs (with the exception of any additional costs arising from a form of delivery you may have chosen other than the most inexpensive, standard delivery that we offer), without delay and, at the latest, within fourteen days from the date we received your cancellation notification for this order. We will use the same payment method for this refund that you used in the original transaction, unless a different method was expressly arranged with you; under no circumstances will you be charged anything due to this refund. We can withhold the refund until we have received the goods, or until you provide proof that you returned the goods, whichever came first.

Data Protection

In view of the regulations in the Federal Data Protection Act, we hereby inform you that your personal data is being collected, stored and used by tekom/tekom Europe/tcworld GmbH for purposes of order fulfillment. Until such time as you revoke your consent, you declare that you agree to be contacted by tekom/tekom Europe and tcworld GmbH by email, in writing or, in special cases, by telephone to inform you about new publications, events and training programs. Final Provisions

German law shall apply without the reference standards of international private law and to the exclusion of the UN Convention on Contracts for the International Sale of Goods (CISGG). If the customer is a consumer, the law of the customer's place of residence may also be applicable, insofar as mandatory consumer law provisions are concerned.

Should one or more provisions of these General Terms and Conditions be invalid in whole or in part or lose their legal validity at a later point, this shall not affect the validity of the remaining provisions.
